Minutes of Annual Parish and Annual Statutory Allensmore Parish Council Meetings held on 18th May 2023 from 7.30pm at Allensmore Village Hall

Part One Annual Parish Meeting (open session)

In attendance: Cllrs J Lawrence, S Williams, J Evans (re-elected as Vice Chair), C Watkinson and T Cramp (re-elected as Chair) and Mrs A Wright, (Clerk) plus Ward Cllr Richard Thomas and two members of the public

Cllr T Cramp welcomed everyone to the meeting and gave a welcome and congratulations to the new Ward Cllr; Richard Thomas.

1. Open Session with parishioners

The question was asked about progress regarding speeding issues. A significant report had been sent to Herefordshire Council on the topic and this had been a matter of record. Feedback had indicated that, unfortunately, there were no resources to progress anything on this at present. Cllr Cramp would send a copy of the report to the new Ward Cllr.

Part Two Annual Meeting of the Parish Council

1. Co-option of councillor(s)

There were currently two vacancies for new councillors, following only five councillors standing at the local parish recent elections. There were no candidates for possible cooption this time. The vacancies would be advertised through the village e mail.

2. Election of Chair and acceptance of office

Cllr Tony Cramp was nominated as Chair of the parish council by Cllr Steve Williams and seconded by Cllr Charles Watkinson. There were no other nominations. Cllr Cramp was duly elected as Chair.

Planning Lead: Cllr Watkinson Lengthsman Lead: Cllr Lawrence Footpaths Lead: Cllr Williams Finance Lead: Cllr Cramp

3. Election of Vice-Chair and acceptance of office

The office of Vice-Chair received one nomination and Cllr. J. Evans was proposed (in his absence) by Cllr J. Lawrence and seconded by Cllr C. Watkinson. Cllr J. Evans had previously indicated he would accept the Office of Vice-Chair.

4. Election of Parish Council Officers (incl. Footpath Officer, Lengthsman Coordinator)

The Planning Sub Committee was confirmed as comprising all members.

The Footpath Officer was confirmed as Cllr Steve Williams

The Finance Working Group was confirmed as all Cllrs.

The Lengthsman Co-ordinator would be Cllr Jeremy Lawrence

5. Apologies for absence

There were apologies for absence received from Cllr Evans.

6. To note Declarations of Interest

There were no declarations of interest recorded.

7. Brief Verbal Reports:

7.1 **Ward Councillor** - The new Ward Cllr; Richard Thomas updated the meeting and advised that there would be a meeting of the full Herefordshire Council on 19th May 2023. The Conservatives had the most seats but not a majority enabling them to form a Conservative Cabinet. The Liberal Democrats would support if agreeing with the policy. The Ward Cllr said that he would be attending all of the parish council meetings where possible and would send a newsletter advising on what was going on at County level and Ward level. The parish council would keep the Ward Cllr informed regarding speeding etc.

11. Planning - to review any planning matters

There were no new planning consultations to review at the time of the meeting.

Cllr Watkinson had circulated an update, with the current position, concerning applications that had been reviewed and commented on, for information purposes. It was agreed that no further comments would be submitted, by the parish council, in respect of agent observations made in reference to a consultation for Trap House.

12. Drainage and related matters – update

The meeting was advised that the pipe-work pending for completion by Herefordshire Council/Balfour Beatty was still awaited. The Ward Cllr had reviewed the commons drainage with a local resident. He would be meeting with the Herefordshire Council/Balfour Beatty drainage teams to follow up.

The Lengthsman Co-ordinator would liaise with the Lengthsman in regard to grant applications and days required. Action was required for Goose Pool and Church Road. Goose Pool could have another pipe installed higher than the existing – attempting to drain the water lying there. Pool Farm jetting of drainage required there.

Clerk would chase up the new Lengthsman Contract and grant information.

A footpath finger post had been knocked down by "Aconbury Sprouts".

13. Road safety and initiatives update – as applicable

Cllr Cramp would send the report with findings on the subject of speeding to the new Ward Cllr.

14. Broadband update

Cllr Cramp gave a brief update on the situation concerning broadband. Airband still ad areas outstanding for connection. The Community Broadband appeared to be "focussing on the big stuff." There was a new officer in post dealing with the situation and negotiating — a small possibility there may be some movement. Open Reach were supposed to be getting fibre sometime between the present date and 2026. Cllr Cramp was chasing for specifics and would circulate any updates.
