## 2. Election of Chair, acceptance of office and signing of forms

The office of Chair received one nomination and Cllr. Tony Cramp was proposed by Cllr Y. Chapman and seconded by Cllr. J. Evans. Cllr. T. Cramp accepted the Office of Chair.

## 3. Election of Vice-Chair, acceptance of office and signing of forms

The nomination for Vice-Chair was postponed until a future meeting.

## 4. Election of Parish Council Officers (incl. Footpath Officer)

The Planning Sub Committee was confirmed as comprising all members.

The Footpath Officer was confirmed as Cllr Steve Williams, nominated by Cllr J Lawrence and seconded by Cllr Cramp.

The Finance Working Group was confirmed as all Cllrs.

The Lengthsman Co-ordinator would be Cllr Jeremy Lawrence, nominated by Cllr Cramp and seconded by Cllr Evans.

## 5. Apologies for absence

There were apologies for absence received from the Cllr C Watkinson.

#### 6. To note Declarations of Interest

There were two declarations of interest recorded. These were for Cllrs J Lawrence and J Evans in relation to planning consultation 210068.

## 7. Brief Verbal Reports:

7.1 **Ward Councillor** The Ward Cllr updated the meeting regarding matters relating to Herefordshire Council. Full Council Meeting for the Annual Meeting held at the Three Counties Hotel. The Newton Farm by-election had been held and there were now 53 ward councillors representing Herefordshire. The Ward Cllr mentioned the Independent Remuneration Panel. The Ward Cllr advised that she would not be supporting an allowance increase for the current year.

The new Chief Executive, Paul Walker, was taking up his role.

Covid cases in Herefordshire remained "quite low"; there had been an isolated spike of the ("Indian" now called "Delta") variant in one small group.

There were lots of consultations in progress. The Housing Strategy consultation closed on 12/06/21.

The Leisure Pool had reopened and pre-booking was required.

Attention was drawn to the Mental Health Helpline and to Dementia Action Week.

# **11. Planning -** to review any planning matters (including NDP outcome)

There were no new planning consultations to review at the time of the meeting.

The parish council had reviewed the following consultation and Cllrs J Lawrence and J Evans had both declared an interest:

The PC comments had been sent to the planning authority.

## The Allensmore Neighbourhood Development Plan

The plan had been adopted at the referendum held on May 6<sup>th</sup> 2021. A clear mandate in favour of the NDP with a majority "yes" vote had been given. A big "Thank you" was recorded to all those who had worked, councillors and non-councillors, on the plan and brought it to the referendum. The plan would be a "useful and living" document and the rolling review of the plan would be on the next agenda.

## 12. Drainage and related matters – update

There were remnants of jetting works to be carried out by the Lengthsman. The Lengthsman had a new jetter coming to replace the one that had broken. A map had been sent of Pool Farm, as to where the water goes, and the ditch had been dug out. It was commented that Balfour Beatty had not yet completed the clearing of items that they had said they would do about twelve months previously. The matter would have to go back to the Locality Steward once Cllr J Lawrence had checked what had been confirmed.

The culvert under the road next to "Thornbrook" a job had been set up for clearing. Further drainage related works were being negotiated with the Lengthsman.

The first tranche of grant funding had been successfully reclaimed.

## **13. Village Matters (brief action points)**

Cllr Williams advised that materials had been obtained by the Lengthsman to carry out works as identified at the last meeting on paths AN25 and AN26. There had been a complaint from Clehonger and this had been also sent to Balfour Beatty. It would be ideal to replace the stiles with self closing kissing gates but Balfour Beatty would replace with "like for like" stiles. Cllr Williams would obtain prices for gates and advise regarding this in terms of cost of gates and the fitting. Three new gates were needed to make a circular walk. Cllr Williams also advised that a solution had been found to a problem on path CH15 and the Locality Steward had been involved in meeting the landowner regarding an issue with path AN3.

Rambles would be starting up again from 1st July.

The suggestion of working with Kilpeck Council regarding speeding and traffic issues on the A465 was noted. Correspondence had been received. Cllrs Evans and Chapman would work with representatives from Kilpeck PC, as a Working Group, to help progress any suggestions. Cllr Cramp would circulate details.

Thanks were recorded for a local litter picker who had cleared the parish of lots of litter. An appropriate letter of thanks would be sent, via the Hereford Times who had published the person's story.
