Minutes of the Allensmore Parish Council Meeting held on 18th January 2024, at the Allensmore Village Hall, from 7.45pm

In attendance: Cllrs T Cramp (in the Chair), J Lawrence, J Evans, C Watkinson, and S Williams plus Mrs A Wright (Clerk), and Ward Cllr Richard Thomas plus three members of the public

1. Introduction and welcome by the Chair

Cllr Tony Cramp (Chair) welcomed everyone to the meeting.

2. Co-option of councillor (2 current vacancies) and acceptance of office

No candidates were presented this time.

3. Apologies for Absence

There were no apologies for absence.

4. Declarations of Interest

There was one declaration of interest, from Cllr Williams, in relation to matters about the Hillside planning application – number 233299.

5. Open Session

There was a resident present who had some concerns about damage done by parking on the grass area next to the Cobhall Common bus shelter. There had been new 9 inch diameter pipe work installed, approximately 12 inches under the ground to help mitigate flooding, and there were concerns that cars parking on top of the grass area may lead to disturbance of the pipe beneath. There was also the churning up of the grass area as a result of the tyres crossing it. There were also potholes in the road in the vicinity of the grass area. The land was publicly owned. The resident had spoken with the owner of the car that was being parked on the grass, and the owner was not seemingly willing to move from the spot. The resident indicated that he would be willing to landscape the area with maybe a bench, rock and a new notice board? The access to the manhole had a "dipstick". There may be a cone(s) placed over it? The vulnerability of the pipe was recorded as a concern. The new pipe was lying over the existing pipe. A referral had been asked, through the Locality Steward, to the team responsible for the drainage situation. The protection of the pipe and safeguarding of the asset from crushing was important. Maybe the team could install verge markers? The matter would be reiterated to the Locality Steward.

Another resident was present and they spoke about the planning consultation for Hillside, number 233299. This was for the "proposed erection of storage barn for purposes related to the management of the agricultural land upon which it is situated and for storage purposes incidental to the enjoyment of Hillside." The parish council heard representation from the applicant and resolved that they would go and meet with the applicant, on site, to look at the situation.

6. Brief Verbal Reports:

6.1 West Mercia Police

Bulletins had been circulated when received.

Lengthsman Co-ordinator

The Lengthsman Co-ordinator advised about works that were planned around Goose Pool, plus Church Road and also there were some considerations of possible works around the area near the Cats Protection, in terms of re-opening a trench system. The co-ordinator would look at this with the Lengthsman.

6.2 Ward Councillor:

Ward Cllr Richard Thomas updated regarding Herefordshire Councils recent road safety initiative, following recent road issues, and this included to renew white lines on the A465, particularly outside the Pontrilas Timber business, as a priority. The Ward Cllr advised how the amount of grant funding available per kilometre for lengthsman activities appeared to have been halved suddenly, with rural parishes getting less per km that urban parishes. It was hoped that this decision would be reversed under review (but this had not been confirmed.)

6.4 Balfour Beatty (Locality Steward)

James Howells, the Locality Steward, had circulated his reports.

6.5 Footpath Officer

Cllr Williams updated regarding the footpath footbridge on AN8 at Willow Brook. The situation had been logged under Log number 13102697 and the Inspector would be coming out to take a look.

7. To approve Minutes of the Parish Council Meeting held on 16th November 2023.
