

Minutes of the Allensmore Parish Council Meeting held on 21st March 2024, at the Allensmore Village Hall, from 7.45pm

In attendance: Cllrs T Cramp (in the Chair), J Lawrence and C Watkinson plus Mrs A Wright (Clerk), and Ward Cllr Richard Thomas

1. Introduction and welcome by the Chair

Cllr Tony Cramp (Chair) welcomed everyone to the meeting.

2. Co-option of councillor (2 current vacancies) and acceptance of office

No candidates were presented this time.

3. Apologies for Absence

There were apologies for absence received from Cllr S Williams. Cllr J Evans was not present.

4. Declarations of Interest

There were no declarations of interest.

5. Open Session

There were no matters raised in the Open Session.

6. Brief Verbal Reports:

6.1 West Mercia Police

Bulletins had been circulated when received.

Lengthsman Co-ordinator

The Lengthsman Co-ordinator advised about works the three schemes that had been identified for works principally at Goose Pool, Church Road and also there were some considerations of possible works around the area near the Cats Protection, in terms of re-opening a trench system. The co-ordinator would check with the Lengthsman regarding the quotation for the trench and drain works near the Cats Protection. More at Agenda number 11.

6.2 Ward Councillor:

Ward Cllr Richard Thomas advised that the amount per kilometre for lengthsman funding had been increased to £120.00. There were to be three grant funded schemes

available: Lengthsman, Public Rights of Way and Drainage Infrastructure. The local plan consultation was underway. Neighbourhood Development Plans could be updated to include specifications such as types of materials to be used in new homes.

6.4 Balfour Beatty (Locality Steward)

James Howells, the Locality Steward, had circulated his reports.

6.5 Footpath Officer

Clr Williams had sent his apologies. He had circulated a report in advance of the meeting. Path AN8 was awaiting an inspection. Path AN6 had received a report that the steps were a little too high and this was being chased up. The 6th April would see another Ramble and Barbeque. APPLICATION NO & SITE ADDRESS: Planning Consultation - 240585 - Land at Church Lane, Church Lane, Allensmore

DESCRIPTION: Application for variation of condition 6 following grant of planning permission P212736/O - (Proposed variation of condition 5 of planning permission 190650 (Site for erection of 6 dwellings, garaging and new vehicular accesses) - to allow minor changes to the site layout and dwelling types) - variation of house type external appearance.

GRID REF: OS 346468, 236004

APPLICATION TYPE: Outline

The parish council discussed the application 240585 and there were no objections. Cllr Watkinson would circulate confirmation and any applicable comments for submission by the Clerk to the Planning Authority in relation to the position of the ditch and whether there was adequate footpath width.

APPLICATION NO & SITE ADDRESS: Planning Consultation - 240562 - Courtlands - A S Organic Ltd, Allensmore, Hereford, Herefordshire HR2 9AB **DESCRIPTION:** Proposed general purpose horticultural storage building and polytunnel.

APPLICATION TYPE: Planning Permission

APPLICATION NO & SITE ADDRESS: Planning Consultation - 240552 - Trap House Farmhouse, Allensmore, Hereford, Herefordshire HR2 9BP

DESCRIPTION: Proposed extension to existing barn.

GRID REF: OS 345245, 235418

APPLICATION TYPE: Planning Permission

The parish council discussed the application 240552 and there were no objections. Cllr Watkinson would circulate confirmation and any applicable comments for submission by the Clerk to the Planning Authority in relation to concern over possible overdevelopment of the site.

11. Update on parish drainage, pipe work and any flooding issues

The council heard that the Goose Pool works had been completed and that all seemed to be okay. The Lengthsman had undertaken a survey during rainy weather and all was "generally good." Grips were being cleaned as required and areas of local flooding were being tackled around "The Butts" and Goose Pool. A further maintenance day would be required. The quote for the French drains was being revisited to double check the specification of the length of trench etc.

On the A465 there was water pooling on the road above the property known as "Courtlands" at HR2 9AB. Water was laying across half the width of the road, on the northbound carriageway. Water was coming out of one drain and flowing down the road and then returning down another drain. Ward Cllr Thomas was dealing with Balfour Beatty on this and also a collapsed drain in the road outside the Three Horseshoes Public House car park.

14. To review the Lengthsman Contract works, grant and update

The grant application and reclaim of spend were in progress. There was damage to a railing on Blackhall Lane following a collision with a vehicle. There was a pole sticking out of the ground that required coning off. The Clerk would contact the Locality Steward about the issue.
